The Chairman announced that Articles of Incorporation will be filed with the Department of State, and that the filing of the Articles of Incorporation should be duly advertised as required by law and instructed the Secretary to cause a copy of the Articles of Incorporation to be prefixed to the minutes.

Upon motion, duly made, seconded and carried, it was

**RESOLVED**, That the Articles of Incorporation of the corporation be and they hereby are accepted and that this corporation proceed to do business thereunder.

The Secretary presented a form of By-Laws for the regulation of the affairs of the corporation, which were read article by article.

Upon motion, duly made, seconded and carried, said By-Laws were unanimously adopted and the Secretary was instructed to cause the same to be inserted in the minute book immediately following the copy of the Articles of Incorporation.

Upon motion, duly made, seconded and carried, the initial number of Directors on the Board of Directors was set at 19.

The Chairman Stated that the next business before the meeting was the election of the Board of Directors.


